ORDER GRANTING APPLICATION TO INTERVENE AND ORDER DIRECTING FILING

On December 12, 2022, Missouri-American Water Company filed the above-referenced application. The City of O'Fallon, Missouri (the City) filed a timely application to intervene. The City supports the application.

The Commission may grant an application to intervene if it finds that the interests of the applicant differs from that of the general public, and that the applicant's interests may be adversely affected by a final order.¹ The Commission finds that the interests of the City differs from those of the general public and may be adversely affected by a final order arising from this case. Therefore, the Commission will grant the application to intervene.

The Commission will now order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The application to intervene filed by the City of O'Fallon, Missouri is granted.
2. The Staff of the Commission shall file a Recommendation no later than February 28, 2023.
3. This order shall be effective when issued.
