**ORDER POSTPONING CONFERENCE AND PROPOSING DATES FOR
RESCHEDULING**

Effective Date: November 9, 2005

On November 1, 2005, the Commission scheduled a conference in these complaint cases for November 15. On November 3, Folsom Ridge, LLC filed a motion requesting that the conference be rescheduled to November 18 because of a conflicting court commitment that would prevent its legal counsel from appearing at the conference. On November 8, the Commission rescheduled the conference for November 18. However, on November 9, one of the complainants, Ben F. Weir, filed a pleading indicating that he would not be available on November 18, and requesting that the conference not be rescheduled.

Obviously, if the proposed conference is to be useful, all parties that want to attend must be able to do so. Therefore, the Commission will postpone the conference. Equally obviously, with multiple complainants and defendants, conflicts on any date chosen are likely. Therefore, before rescheduling the conference, the Commission will give all the

parties the opportunity to inform the Commission of their conflicts with several possible dates.

If any party has a conflict that would prevent them from participating in the conference on any date, please file a letter with the Commission identifying that conflict by November 16. The conference will then be rescheduled for the first available date that does not have a conflict.

IT IS THEREFORE ORDERED:

1. That the conference scheduled for November 18, 2005, at 10:00 a.m., is postponed.
2. That if any party has a conflict that would prevent them from participating in the conference on any of the dates listed in this order, they shall so inform the Commission by filing a letter identifying that conflict by November 16, 2005.

3. That the Commission's Data Center shall mail a copy of this order to the Missouri Department of Natural Resources.

4. That this order shall become effective on November 9, 2005.
