ORDER DIRECTING STATUS UPDATE

On June 7, 2017, the Commission issued its Order Canceling Certificate and Accompanying Tariff, which directed Airnex's certificate of service authority and accompanying tariff be cancelled. On June 13, 2017, Staff filed a Motion to Suspend Cancellation. Staff explained it had been in contact with Airnex and recommended the cancellation of Airnex be suspended while Airnex supplies required documentation. Several of Staff's Status Updates have been filed since then.

On August 11, 2017, Staff filed a Status Update stating the Commission has received all necessary paperwork, and an assessment payment check. The check was made out to the Commission for the wrong amount. Staff has spoken to a company representative numerous times who stated a correct check would be forthcoming. Staff again asks for additional time to allow Airnex the opportunity to reissue a corrected assessment payment and proposes to file an update by August 25, 2017. Staff stated they will either file a motion to withdraw its motion to


cancel the certificate if a corrected check is received, or Staff will renew its motion to cancel if a corrected check has not been received.

The Commission has withdrawn its order canceling Airnex's certificate and will take no further action regarding that certificate at this time. The Commission will direct Staff to file a status update.

THE COMMISSION ORDERS THAT:

1. Staff shall file a status report no later than August 25, 2017.
2. This order shall be effective when issued.
