## ORDER WITHDRAWING ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

On June 7, 2017, the Commission issued its Order Canceling Certificate and Accompanying Tariff, which directed Airnex's certificate of service authority and accompanying tariff be cancelled. That order will become effective on June 17, 2017. On June 13, 2017, Staff filed a Motion to Suspend Cancellation. Staff explains it has been in contact with Airnex and recommended the cancellation of Airnex be suspended while Airnex supplies required documentation. Staff plans to file an update on June 30, 2017.

Staff's Request to suspend the cancellation of Airnex's certificate is reasonable. The Commission will accomplish that by withdrawing its June 7 order canceling the certificate.

#### THE COMMISSION ORDERS THAT:

1. The Commission's June 7, 2017 Order Canceling Certificate and Accompanying Tariff of Airnex Communications, Inc. is withdrawn.

2. Staff shall file a status report no later than June 30, 2017.
