ORDER GRANTING WAIVERS

On August 28, 2008, House Bill 1779 became effective, modifying §392.420, RSMo 2000, so that it now provides, in pertinent part:

The commission is authorized, in connection with ... a certificate of interexchange ... service authority ... to entertain a petition to suspend or modify the application of its rules or the application of any statutory provision contained in sections 392.200 to 392.340 if such waiver or modification is otherwise consistent with the other provisions of sections 392.361 to 392.520 and the purposes of this chapter.

On May 19, 2010, Global Crossing Telecommunications, Inc. filed a request with the Missouri Public Service Commission ("Commission") that the Commission waive certain rules and statutory provisions pursuant to Section 392.420, RSMo Supp 2009.

On June 11, 2009, the Commission Staff submitted its memorandum concerning the request. It noted that:

1. The company is an interexchange telecommunications companies as that term is used in Section 392.420.

2. The company is currently compliant in obligations relating to Commission assessment, Missouri Universal Service Fund, Relay Missouri, and the submission of an annual report.

The waivers requested by the Company are:

The Staff recommends that the Commission grant the requested waivers and require Global to submit revised tariffs reflecting the waivers.

Based on the requirements of Section 392.420 and 392.245.5(8) and the verified application and Staff recommendation, the Commission finds that the waivers are consistent with the provisions and purposes of Chapter 392, RSMo. Therefore, the Commission shall grant the requested waivers.
