

## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 30, 2016

Effective Date: July 10, 2016

On June 13, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting Telecare, Inc.'s ("Telecare") certificate of service authority and accompanying tariff to provide interexchange telecommunications services in the State of Missouri be canceled.

In File Number TA-94-151, the Commission granted Telecare a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Telecare is deficient in the filing of the Company's Statement of Revenue for calendar years 2013, 2014 and 2015. It did not pay its Fiscal Year assessment of \$46.77. In addition, Telecare's telephone was disconnected on June 1, 2016. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On June 15, 2016, the Commission issued an Order Establishing Time to Respond allowing parties until June 27, 2016, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Telecare, Inc., shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange telecommunications services granted to Telecare, Inc., in File Number TA-94-151, is canceled.
2. Telecare, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on July 10, 2016.
4. This case may be closed on July 11, 2016.




