STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

- 1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize the use of the fictitious name "ONE Communications" by Computer Telephone Corp. in lieu of its current fictitious name of "CTC Corp."
- 2. The company has fulfilled the requirements of the Commission's rule governing name changes at 4 CSR 240-2.060(5) in that the request contains (1) a Registration of Fictitious Name issued by the Missouri Secretary of State (demonstrating that Computer Telephone Corp. has registered the name ONE Communications for use in Missouri); and (2) an adoption notice and revised tariff title page identifying the new name.
- 3. Customers will be notified of the name change in compliance with 4 CSR 240-3.545(20), and Staff has reviewed the notice and found it acceptable.
- 4. The company has submitted new tariff sheets with an effective date of September 25, 2006. Staff has reviewed the new tariff sheets and recommends that the Commission approve them.

WHEREFORE, Staff recommends that the Commission issue an order acknowledging that Computer Telephone Corp. will do business under the fictitious name of ONE Communications rather than under the name of CTC Corp.; and approving the tariff sheets filed to effectuate that name change with an effective date of September 25, 2006.
