ORDER RECOGNIZING CHANGE OF CORPORATE NAME
AND APPROVING TARIFF

Issue Date: April 24, 2007

Effective Date: May 5, 2007

On April 5, 2007, Inmate Calling Solutions, LLC d/b/a ICSolutions ("ICSolutions") filed a letter requesting that the Missouri Public Service Commission acknowledge its recent corporate name change from Inmate Calling Solutions, LLC ("ICS") and approve a replacement tariff reflecting that name change. ICS is currently authorized to provide competitive interexchange and nonswitched local exchange telecommunications services in the state of Missouri through a certificate issued by the Commission in Case Number XA-2004-0478.

Accompanying the letter was a document showing that ICS registered the fictitious name "ICSolutions" with the Missouri Secretary of State on January 31, 2007, and that this registration does not expire until January 31, 2012. Also attached to the letter was a replacement tariff reflecting the company's new name, Inmate Calling Solutions, LLC d/b/a ICSolutions. The replacement tariff, which has been designated as Tariff No. YX-2007-0724, had an effective date of May 5, 2007. The letter stated that the tariff contains no substantive changes and reflects only ICS's adoption of the new name.

On April 6, 2007, the Commission directed its Staff to commence an investigation and promptly file a report containing its recommendation as to whether the Commission should recognize ICS's name change and approve the accompanying replacement tariff sheets. On April 18, 2007, the Staff of the Commission filed a verified Memorandum recommending that the Commission recognize ICS's name change to ICSolutions and approve the accompanying tariff sheets with an effective date of May 5, 2007. Staff notes that ICS's letter complies with the applicable Commission Rules governing utility company name changes and setting forth filing requirements for telecommunications company tariffs,¹ even though ICS cannot provide direct customer notice of the name change due to the peculiar nature of the telephone services it provides.²

The Commission has reviewed ICS's pleadings and Staff's Memorandum, and finds that the change of name to ICSolutions will be recognized. The Commission further finds that the revised tariff reflecting the change of name will be approved.

IT IS ORDERED THAT:

1. The change of name from Inmate Calling Solutions, LLC to Inmate Calling Solutions, LLC d/b/a ICSolutions is recognized.
2. Inmate Calling Solutions, LLC d/b/a ICSolutions' replacement tariff, Tariff No. YX-2007-0724, is approved to become effective on May 5, 2007. The tariff approved is:

¹ These regulations include 4 CSR 240-2.060(5), 4 CSR 240-3.020(1), and 4 CSR 240-3.545(20).

² As noted by Staff in the Memorandum, ICS serves inmates at correctional facilities and provides automated operator-assisted calling services to the prisoners. Because the company does not provide presubscribed services and lacks address and contact information for both the inmates and the people they call, no direct customer notice can be provided. However, ICS does notify correctional facility management personnel of the names of the providers who serve the prisons, and also provides this information on its website.

3. This order shall become effective on May 5, 2007.
4. This case may be closed on May 6, 2007.
