ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: December 30, 2014

Effective Date: December 31, 2014

On November 21, 2014, the Staff of the Missouri Public Service Commission filed a motion requesting Public Wireless, Inc. ("Public Wireless") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2010-0022, the Commission granted Public Wireless a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Public Wireless contacted Staff stating Public Wireless was no longer providing service in Missouri and requested the Commission cancel Public Wireless's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On November 24, 2014, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 5, 2014. No objections or requests for a hearing were filed.

On December 17, 2014, the Commission issued an Order Canceling Certificate and Accompanying Tariff to be effective December 27. On December 17, 2014, the company filed a statement in EFIS indicating it no longer wanted to relinquish its certificate. The Commission withdrew its cancellation order. On December 23, 2014, Public Wireless withdrew its opposition to the December 17 Order Canceling Certificate. On December 29, 2014, Staff filed a response recommending the Commission cancel the tariff and certificate of service authority of Public Wireless, Inc. to provide interexchange telecommunications service in Missouri. Staff further advised the Commission to cancel the certificate and tariff before January 1 so that Public Wireless, Inc. will not be required to file an annual report with the Commission for the new year.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion and Public Wireless, Inc.’s request, the Commission finds that the certificate of service authority and accompanying tariff granted to Public Wireless, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Public Wireless, Inc., in File Number XA-2010-0022, is canceled.
2. Public Wireless, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on December 31, 2014.
4. This case may be closed on January 1, 2015.
