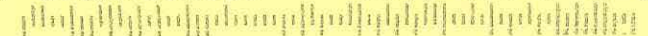

## ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On August 29, 2019, the Staff of the Public Service Commission filed a motion requesting that the Commission cancel AIRNEX Communications, Inc.'s certificate of service authority. The Commission granted AIRNEX certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri in File Number TA-99-355. The company has one applicable tariff that is to be canceled.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.

### THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing a pleading no later than September 9, 2019, with:




