ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Effective Date: December 26, 2013

On October 24, 2013, the Staff of the Missouri Public Service Commission filed a motion requesting that the Commission cancel the certificate of service authority and associated tariff of Association Administrators, Inc. ("Company"). The Company was granted its certificate on June 13, 1997 in File No. TA-97-457. The Company's tariff, assigned tracking no. JX-2003-0095, was also approved.

In support of its motion, Staff states that the Company has failed to file its calendar year 2012 annual report with the Commission as required by Section 392.210.1, RSMo 2000, and Commission Rule 4 CSR 240—3.540(1). Staff recommends that the Commission cancel the Company's certificate of service authority to provide interexchange telecommunications services in the State of Missouri and the Company's associated tariff.

On October 25, 2013, the Commission issued an *Order Directing Filing*, allowing the Company to respond to Staff's motion no later than November 25, 2013. The Company did not file a response to the motion.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410(5), RSMo Supp. 2012, which states that "[a]ny certificate of service

authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.” Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Association Administrators, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority to provide interexchange telecommunications services in the State of Missouri granted to Association Administrators, Inc. in File No. TA-97-457 is canceled.
2. Association Administrators, Inc.’s tariff, assigned tracking no. JX-2003-0095, is canceled.
3. Association Administrators, Inc. shall notify the Commission when transfer of its customers to another provider is complete.
4. This order shall become effective on December 26, 2013.
5. This case may be closed on December 27, 2013.
