ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 6, 2017

Effective Date: September 16, 2017

On August 17, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Business Discount Plan, Inc.'s ("Business Discount") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled at the company's request.

In File Number TA-96-113, the Commission granted Business Discount a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Business Discount notified the Commission in its Statement of Revenue that the company was no longer providing service in Missouri. Business Discount also requested the Commission cancel its certificate of service authority. Staff recommends the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On August 17, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until August 28, 2017, to file an objection or request a hearing. No objections or requests for a hearing were filed.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Business Discount's request, and Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Business Discount Plan, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Business Discount Plan, Inc., in File Number TA-96-113, is canceled.
2. Business Discount Plan, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on September 16, 2017.
4. This case may be closed on September 17, 2017.




