ORDER CANCELLING CERTIFICATE OF INTEREXCHANGE SERVICE AUTHORITY AND APPLICABLE TARIFF

Issue Date: November 16, 2021

Effective Date: December 16, 2021

On October 29, 2021, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange telecommunications service authority of Advantage Telecommunications, Corp. (Company). On March 8, 1999, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. TA-99-328. The Company also has applicable Tariff No. JX-2003-0075. Staff's motion states that the Company filed a letter with the Commission on October 28, 2021, asking the Commission to cancel the certificate and applicable tariff. The letter also states that the Company no longer offers telecommunications services in Missouri and that no customers will be affected.

On November 1, 2021, the Commission issued its order that anyone wishing to respond to Staff's Motion or request a hearing do so by filing a pleading no later than November 12, 2021. There were no such filings. The Commission need not hold a hearing

if, after proper notice and opportunity to intervene, no party requests such a hearing.¹
Therefore, the Commission may cancel the certificate based on Staff's motion.

THE COMMISSION ORDERS THAT:

1. The certificate of authority and the applicable tariff, JX-2003-0075, of Advantage Telecommunications, Corp. are cancelled.
2. This order shall be effective on December 16, 2021.
3. This file shall be closed on December 17, 2021.
