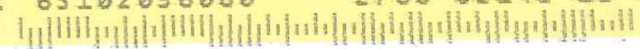

ORDER RE-ESTABLISHING TIME TO RESPOND

The Commission received returned mail from the address it has on file for Norstar Telecommunications, LLC (Norstar) in Vienna, Virginia. The presiding officer has discovered via web search an alternate address of 8200 Greensboro Dr. Suite 900 Mclean, Virginia.¹ This order is being re-issued such that Norstar will be sent a copy of this order to the new address, and be given time to respond.

On March 24, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificate to provide interexchange and non-switched local exchange telecommunications service authority and currently active tariff of Norstar Telecommunications, LLC. The Commission granted Norstar Telecommunications, LLC a certificate to provide interexchange and non-switched local exchange telecommunications service authority in File No. XA-2007-0482.

Sections 392.210 and 392.390, RSMo set forth various requirements for telecommunications companies. Those requirements include filing an annual report, filing a Statement of Revenue report, and paying the Missouri Commission assessment.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.² Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 30 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than June 12, 2023.




