
On May 22, 2017, the Staff of the Missouri Public Service Commission (Staff) filed a motion to cancel the certificate of interexchange telecommunication service authority of Airnex Communications, Inc. ("Airnex"), in the State of Missouri.

On June 7, 2017, the Commission issued its order canceling the company's certificate and accompanying tariff. On June 13, 2017, Staff filed a Motion to Suspend Cancellation and explained that Staff had been in contact with Airnex and recommended the cancellation be suspended while Airnex provides required documentation to the Commission. On June 14, the Commission issued an Order Withdrawing Order Canceling Certificate and Accompanying Tariff.

On August 23, 2017, Staff filed its Status Update and stated it would like the Commission to withdraw its June 7 Order and to permit Airnex to continue serving as an interexchange provider in the State of Missouri.

Because the Commission's June 7 Order has already been withdrawn, no further action is required. Airnex's certificate of service authority remains in effect, and this file may be closed.
