## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 11, 2019

Effective Date: October 11, 2019

On August 29, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Airnex Communications, Inc.'s ("Airnex") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication service in the State of Missouri be cancelled.

In File Number TA-99-355, the Commission granted Airnex a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Airnex contacted Staff via letter stating Airnex was no longer providing service in Missouri and requesting the Commission cancel Airnex's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On August 29, 2019, the Commission issued an Order Establishing Time to Respond allowing parties until September 9, 2019, to file an objection or request a hearing. No objections or requests for a hearing were filed.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Airnex Communications, Inc., shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Airnex Communications, Inc., in File Number TA-99-355, is canceled.
2. Airnex Communications, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on October 11, 2019.
4. This case may be closed on October 12, 2019.




