STAFF MOTION

COMES NOW the Staff of the Missouri Public Service Commission and for its Motion states:

1. On August 28, 2011, §392.461 was enacted by H.B. 338, allowing regulated telecommunications companies to elect a waiver of the requirement that they offer retail services to residential or business end users only through tariff. The new law allows companies to withdraw such tariffs upon written notice to the Commission, but requires the company to publish generally available retail prices on a website.

2. On November 1, 2011, Verizon Enterprise Solutions, LLC notified the Commission of its withdrawal of its Tariff No. 4, to be effective December 1, 2011. The Company noted the address of the website on which its rates, terms and conditions are available.

3. The Staff has reviewed the Notice, and finds that it comports with the Commission's Rules concerning the withdrawal of tariffs (the thirty-day notice in 4 CSR 240-3.545(18)) and the provisions of §392.461.

WHEREFORE, the Staff moves that the Commission allow the withdrawal of the above-referenced tariff to take effect by operation of law, after which this matter may be closed without further action.
