The Honorable Dale Hardy Roberts:

On April 18, 2002, Broadview NP Acquisition Corp. d/b/a Broadview Net Plus ("BNP"), by their counsel, filed an Application regarding the transfer of assets, including customers, of Network Plus, Inc. ("Network Plus") to BNP. This Application was approved by the Missouri Public Service Commission (the "Commission") on June 11, 2002, with an effective date of June 21, 2002. BNP's request for authority to provide interexchange service to enable it to serve the former customers of Network Plus was issued on May 21, 2002 with an effective date of May 30, 2002 in Case No. XA-2002-1029. This letter is to advise the Commission that the transaction that was the subject of the Application is complete. BNP is now serving the former customers of Network Plus in Missouri.


As described in the Application, this transfer is transparent to customers as they are currently continuing to receive service pursuant to the same rates, terms and conditions of service. To that end, BNP has provided the Commission with the necessary tariffs and the Parties hereby request that Network Plus' tariffs be cancelled. In addition, at this time, Network Plus is no longer providing service in Missouri, and requests that Network Plus' authority to provide interexchange service pursuant to its certificate granted on January 5, 1993, in Case No. TA-93-2, be surrendered.
