### STAFF RECOMMENDATION

COMES NOW the Staff of the Public Service Commission, and for its recommendation in this matter, states:

- 1. On October 31, 2005, NOSVA Limited Partnership (NOSVA) and Red River Networks, LLC (RRN) jointly filed an Application ("Joint Application") seeking authority from the Commission for NOSVA to acquire certain Missouri assets of RRN.
- 2. NOSVA holds a certificate to provide intrastate, interexchange telecommunications services in Missouri under Case No. TA-94-153.
- 3. The transfer of assets is governed by Section 392.300 and 4 CSR 240-3.520. Applicable case law provides that the Commission may "not withhold its approval of the disposition of assets unless it can be shown that such disposition is detrimental to the public interest." *State ex rel. Fee Fee Trunk Sewer, Inc. v. Litz*, 596 S.W.2d 466, 468 (Mo.App. E.D. 1980), citing to *State ex rel. City of St. Louis v. Public Serv. Comm'n of Mo.*, 73 S.W.2d 393, 400 (Mo. banc 1934).
- 4. In the attached Memorandum, the Staff summarizes its review of the transaction between NOSVA and RRN and concludes that the transfer of assets will not be detrimental to the public interest.

RRN will no longer be offering telecommunications services in Missouri and RRN, therefore, request that the Commission grant it authority to discontinue service upon the transfer of its

In the Joint Application, the parties state "upon completion of the Transaction,

customers to NOVSA." Representatives of RRN have reported that there are no Missouri

customers currently served by RRN and therefore Staff recommends that RRN's certificate and

tariff be cancelled.

WHEREFORE, Staff recommends that the Commission enter an order approving the

transfer of telecommunications assets from Red River Network, LLC to NOVSA Limited

Partnership as proposed in the Joint Application, and canceling Red River Network LLC's

certificate of service authority and tariff.

- 5. Following this transaction, the Certificate to Provide Service and Tariff of RRN are to be cancelled.
- 6. RRN representatives report that there are no retail customers currently served by RRN in Missouri. As there are no Missouri customers that will be affected by this transaction, no notification to customers is necessary. Therefore, NOSVA does not propose to adopt RRN rate plans into its Missouri tariff.
