## ORDER RECOGNIZING NAME CHANGE

On February 22, 2022, ExteNet Systems, LLC filed a letter informing the Commission that it has changed the name by which it provides interexchange and non-switched local exchange service in Missouri from ExteNet Systems, Inc. to ExteNet Systems, LLC. On the same date, ExteNet Systems, LLC filed updated tariff sheets reflecting the name change with an issue date of February 18, 2022, and an effective date of March 20, 2022.

On March 9, 2022, the Commission's Staff filed a recommendation that the Commission recognize the name change and approve the updated tariff sheets to go into effect on March 20, 2022. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of ExteNet Systems, Inc. to ExteNet Systems, LLC.
2. The updated tariff sheets filed by ExteNet Systems, LLC (Tracking No. YX-2022-0224) will be allowed to go into effect by operation of law on March 20, 2022.
3. This order shall be effective when issued.

4. This file shall be closed on March 11, 2022.
