### ORDER RECOGNIZING NAME CHANGE

Crosstown Fiber IL LLC submitted a letter on November 22, 2022, advising that it has changed its corporate form from a Texas corporation to an Illinois limited liability company, changed its name from Netsync Fiber, Inc. to Crosstown Fiber IL LLC, and became an indirect, wholly-owned subsidiary of Crosstown Fiber Holdings LLC. The company currently does not have any customers in Missouri and does not have a Missouri tariff. The company submitted a revised letter on December 6, 2022.

On December 7, 2022, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

- 1. The Commission recognizes Netsync Fiber, Inc.'s name change to Crosstown Fiber IL LLC.
