On January 13, 2009, First Choice Technology ("First Choice") and NetLojix Telecom, Inc. ("NetLojix") (collectively "Applicants"), filed an application, pursuant to RSMo Section 392.300 and 4 CSR 240-2.060 and 3.525, requesting that the Commission grant them the authority necessary to consummate transactions involving the transfer of NetLojix's Missouri residential and business long distance customer accounts to First Choice. The Applicants represent that after consummation of the transaction, First Choice will provide telecommunications services to all of the former customers of NetLojix, and NetLojix will cease operations in Missouri and surrender its Missouri certificate of service authority and tariff.

The Commission has determined that proper parties should be given notice and opportunity to intervene in this matter. The Commission finds that proper persons should be allowed 15 days from the issuance of this order to file a request for intervention or a motion for hearing. each intrastate interexchange telecommunications provider certificated to operate in Missouri.
