STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation respectfully states:

1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize the change of name of McLeodUSA Telecommunications Services, Inc. by the addition of the d/b/a PAETEC Business Services.

2. The company has fulfilled the requirements of the Commission's rule governing name changes at 4 CSR 240-2.060(5) in that the request contains a clear statement of the old and new names, and the request was accompanied by (1) a certificate of registration of a fictitious name issued by the Missouri Secretary of State; and (2) adoption notices and revised tariff title pages identifying the new name.

3. Customers will be notified of the name change at or before the next billing cycle.

4. In conjunction with and to effectuate the name change, the company has submitted revised tariff sheets with an effective date of March 22, 2008. Staff has reviewed the new tariff sheets and recommends that the Commission approve them.

WHEREFORE, Staff recommends that the Commission issue an order acknowledging that McLeodUSA Telecommunications Services, Inc. has changed its

name by adding the d/b/a PAETEC Business Services and approving the tariff sheets filed to effectuate that name change.




