## MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority and applicable tariff of AIRNEX Communications, Inc., (Company) and states:

- The Commission previously granted a certificate to the Company April 6,
   1999, to provide intrastate interexchange service authority in Case No. TA-99-355. The
   Company has a currently effective tariff, Tariff No. JX-2003-0081.
- 2. The Company notified the Commission August 19, 2019, that it wished to voluntarily relinquish all of its authority in Missouri in a letter filed as Non Case Filing BCES-2020-0085 and attached as Appendix A.
- 3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel.* Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications services in Missouri and applicable tariff of AIRNEX Communications, Inc.
