ORDER DIRECTING STAFF TO INVESTIGATE AND FILE A REPORT

On December 15, 2006, The Pager Company d/b/a The Pager & Phone Company (“Pager Company”) filed a letter notifying the Missouri Public Service Commission of a corporate name change to YourTel America, Inc. (“YourTel”). Accompanying the letter are documents showing that Pager Company amended its Articles of Incorporation to change its corporate name to YourTel on December 4, 2006, and that the Missouri Secretary of State issued a Certificate of Amendment registering the name change on December 7, 2006. Two revised tariff sheets which reflect the name change are also attached to the letter, including a replacement cover page and a new adoption notice.¹ Finally, the letter includes a copy of a notice prepared by Pager Company informing its customers of the name change, which is scheduled to be delivered on or before Pager Company’s next billing cycle. The letter and attachments substantially comply with the applicable Commission Rules governing the contents of applications for corporate name changes and setting forth filing requirements for telecommunications company tariffs.²

Although the issues presented in this case are neither involved nor complicated, the Commission would nevertheless like to have the benefit of a brief investigation by its Staff before it further considers this matter. Therefore, Staff will be directed to commence an investigation and promptly file a report containing its recommendation as to whether the Commission should recognize Pager Company's name change and approve the accompanying tariff sheets.

IT IS ORDERED THAT:

1. The Staff of the Missouri Public Service Commission shall promptly commence an investigation into the merits of the application filed by The Pager Company d/b/a The Pager & Phone Company on December 15, 2006.
2. The Staff of the Missouri Public Service Commission shall file a report concerning the results of its investigation no later than noon on Friday, January 5, 2007.
3. This order shall become effective on December 19, 2006.
