## ORDER RECOGNIZING CORPORATE NAME CHANGE AND APPROVING TARIFF SHEETS

Issue Date: May 22, 2007 Effective Date: June 3, 2007

**Syllabus:** This order recognizes AmeriVision Communications, Inc., d/b/a Lifeline's, name change to AmeriVision Communications, Inc. d/b/a Affinity 4, and approves the accompanying tariff sheets.

On May 2, 2007, AmeriVision Communications, Inc., d/b/a Lifeline, advised the Commission that it had changed its name to AmeriVision Communications, d/b/a Affinity 4. Affinity 4 also filed a tariff on May 2, and a substitute tariff on May 17, effective June 3, 2007.

On May 21, Staff filed its Recommendation. Staff stated that Affinity 4 has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the new tariff.

The Commission has reviewed the application, finds that it substantially complies with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), and finds that it should recognize the name change. The Commission will also approve the tariff sheets.

#### IT IS ORDERED THAT:

- 1. The Commission recognizes the name change of AmeriVision Communications, Inc., d/b/a Lifeline, to AmeriVision Communications, Inc. d/b/a Affinity 4.
- 2. The Commission approves the tariff sheets AmeriVision Communications, Inc. d/b/a Affinity 4, filed on May 2, 2007, as substituted on May 17, 2007, reflecting its new name. Those tariff sheets were assigned tariff file number YX-2007-0785, and are approved for service on and after June 3, 2007. The tariff sheets approved are:
