**Staff's Corrected Recommendation Regarding
Compliance Tariffs**

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and hereby corrects its earlier *Recommendation* that inadvertently neglected to list four sheets not included in the original batch of Compliance Tariffs.¹ As directed by the Commission's *Order* of November 15, 2016, Staff states as follows for its recommendation regarding the Company's Compliance Tariffs; to-wit, that the same should be **APPROVED** for service rendered on and after December 22, 2016, because Staff has examined the proposed sheets and determined that they comply with the Commission's *Order Approving Stipulations And Agreements, Rejecting Tariffs, Cancelling True-Up Hearing, And Ordering Filing Of Compliance Tariffs* of September 28, 2016.
