## NOTICE AND ORDER SCHEDULING AN ON-THE-RECORD PRESENTATION

The Missouri Public Service Commission is scheduling an on-the-record presentation regarding the *Non-Unanimous Stipulation and Agreement*<sup>1</sup> and the *Non-Unanimous Stipulation and Agreement Regarding Pensions and Other Post-Employment Benefits*.<sup>2</sup> The parties' desire for a swift resolution of this action, their need for the Commission's guidance, and the nature of the interests they represent, constitute a public interest<sup>3</sup> and a public necessity<sup>4</sup> that require a setting for the on-the-record presentation as set forth below, and make this setting reasonable.

### THE COMMISSION ORDERS THAT:

1. The Commission will convene an on-the-record presentation described in the body of this order on September 22, 2016, immediately after the Commission's agenda meeting. The on-the-record presentation will convene in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.

2. The Governor Office Building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to
