The Commission received a stipulation and agreement ("Agreement"),¹ which includes a request for approval.²

At the August 4, 2016, pre-hearing conference, KCP&L Greater Missouri Operations Company and Midwest Energy Consumers Group stated that granting that request will facilitate the settlement of other issues, and asked for an expeditious ruling. No party to this action objected. The Commission is considering making that ruling as part of the agenda at its open meeting on August 10, 2016, at 11:00 a.m.

The Agreement provides:

The Signatories will make available, at any on-the-record session, their witnesses and attorneys on the issues resolved by this Agreement, so long as all parties have had adequate notice of that session. The Signatories agree to cooperate in presenting this Agreement to the Commission for approval [³]

Therefore, the Commission will order the signatories make witnesses and attorneys available as follows.
