On February 10, 2017, the Commission received a Non-Unanimous Partial Stipulation and Agreement ("Stipulation"). Assuming no party objects to the issues being resolved in the Stipulation¹, it appears that Rate Design/Class Cost of Service, Revenues, Clean Charge Network, and Customer Experience are the remaining issues that the Commission must hear. In addition, some witnesses for issues that have previously been tried are still scheduled to testify out of order.

So that the Commission may prepare for the remainder of the hearing, the Commission will direct its Staff to file an updated list of issues and witnesses that still need to be heard.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a pleading as directed above no later than February 15, 2017.
