STAFF MOTION

COMES NOW the Staff of the Missouri Public Service Commission and for its Motion, states as follows:

1. On September 2, 2010 Telrite Corporation (“the Company”), an interexchange and wireless carrier, filed an application with the Missouri Public Service Commission seeking designation as an Eligible Telecommunications Carrier (“ETC”) for the purpose of receiving federal universal service fund support for wireless service to low income customers. That designation, to provide wireless Lifeline Service, was granted on November 10, 2010.

2. In the attached Memorandum, the Staff discusses the fact that the Company offers the wireless Lifeline Service under the name “Life Wireless” and that this “d/b/a” is properly registered with the Secretary of State. Although the Company is also an interexchange carrier, this name does not apply to its interexchange service, but only to its wireless Lifeline Service. There are no tariffs applicable to the wireless Lifeline Service and customer notice is not an issue, as the Company has been using the d/b/a without Commission recognition for some time.

WHEREFORE, the Staff moves that the Commission recognize the Company’s name as Telrite Corporation d/b/a Life Wireless solely in its designation as an Eligible

Telecommunications Service for the receipt of low-income support from the federal Universal Service Fund and alter applicable records accordingly.

On May 29, 2012, the Missouri Public Service Commission (Commission) received notification from Brian Lisle, President of Telrite Corporation (Telrite or Company), advising the Commission that Telrite is offering service in the State of Missouri under the name Life Wireless.

The company previously registered the d/b/a name, Life Wireless, with the Missouri Secretary of State on January 30, 2012. Mr. Lisle informed Staff that Telrite Corporation has been using its d/b/a name, Life Wireless, since being granted ETC designation in 2010. The name Life Wireless has previously been used in Missouri advertisements and enrollment forms; thus there is no change in company name from the customer's perspective according to Mr. Lisle.

The company's designation should now reflect the name Telrite Corporation d/b/a Life Wireless.
