STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On March 9, 2009, NYNEX Long Distance Company d/b/a/ Verizon Enterprise Solutions filed a new tariff (P.S.C. MO No. 4), with a proposed effective date of April 9, 2009, to reflect its change of name to Verizon Enterprise Solutions, LLC.

2. Commission rule 4 CSR 240-2.060 provides:

(5) A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provision of these rules, the items required herein may be filed by a nonattorney. Applications for approval of a change of name shall include:

(A) A statement, clearly setting out both the old name and the new name;

(B) Evidence of registration of the name change with the Missouri secretary of state; and

(C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.

3. In the attached Memorandum, which is labeled Appendix A, Staff recommends that the Commission recognize the new name. The application clearly sets out the old name of NYNEX Long Distance Company d/b/a Verizon Enterprise Solutions and the new name of Verizon Enterprise Solutions, LLC. The application includes evidence of registration of the

name change with the Missouri Secretary of State. The application includes a new tariff with the new name.

4. Commission rule 4 CSR 240-3.545 (20) requires the applicant to notify its customers at or before the next billing cycle of any name change affecting customer recognition of the company. Staff suggests that this rule will have been satisfied because the customers will be notified at or before the next billing cycle of any name change.

WHEREFORE, Staff recommends that the Commission issue an order to recognize the name change from NYNEX Long Distance Company d/b/a Verizon Enterprise Solutions to Verizon Enterprise Solutions, LLC, and to approve the new tariff.

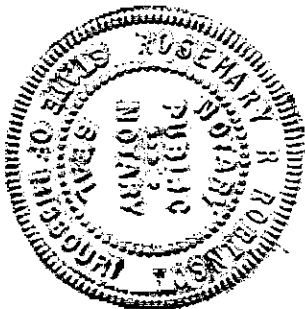
