STAFF'S RECOMMENDATION REGARDING COMPLIANCE TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and, as directed by the Commission's *Order* of May 15, 2017, states as follows for its recommendation regarding the Company's Compliance Tariffs; to-wit, that the same should be **APPROVED** for service rendered on and after May 28, 2017, because Staff has examined the proposed sheets and determined that they comply with the Commission's *Report and Order* of May 3, 2017.

Regarding Kansas City Power and Light Company's ("KCPL") *Motion for a Delayed Implementation Date for Line Extension Tariffs*, Staff recommends the Commission generally approve KCPL's request to delay the implementation of the revised extension policy, but does not recommend that the policy be delayed until January 1, 2018. If the Commission generally approves KCPL's request to delay implementation, but modifies the relief granted to a date other than January 1, 2018, Staff recommends the Commission direct KCPL to file sheets 1.30, 1.31, and 1.32A in substantially the same form as they were substituted on May 15, 2017, but replacing the references to January 1, 2018 with the date the Commission finds appropriate.

Staff also recommends that KCPL make a tariff filing after the conclusion of this rate case to remove the Smart Grid tariff sheets, as this program ended in 2014.

The tariff sheets affected are as follows: PSC Mo. No. 7 Sheet No. 43AA through Sheet No. 43AH and Sheet No. 43AK through Sheet No. 43AQ.

WHEREFORE, Staff prays that the Commission will issue an order that approves the following proposed tariff sheets, as filed on May 9, 2017 and May 16, 2017, and substituted on May 15, 2017 and May 16, 2017, for service rendered on and after May 28, 2017:
