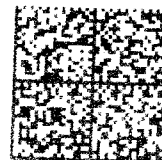

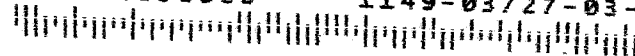

ORDER DIRECTING NOTICE AND ESTABLISHING INTERVENTION DATE

On June 1, 2016, Kansas City Power & Light Company (KCP&L) filed a tariff to adjust the rate of its Demand Site Investment Mechanism (DSIM) Rider. KCP&L's filing is for a first accumulation period under the DSIM that was originally approved by the Commission in File No. EO-2015-0240. KCP&L's tariff sheet bears an effective date of August 1, 2016. Commission Rule 4 CSR 240-20.093(4) requires the Commission's Staff to examine the information filed by KCP&L and determine if the proposed adjustment is in accordance with the Commission's rules and Section 393.1075, RSMo (Cum. Supp. 2013).

The Commission will establish a deadline for Staff to file its recommendation. Consistent with 4 CSR 240-3.163(9)(A), the parties to File No. EO-2015-0240 are automatically considered parties to this adjustment matter. The Commission will establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in KCP&L's service area. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving KCP&L's service area and to the members of the Missouri General Assembly representing the residents of KCP&L's service area.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall add all parties from File No. EO-2015-0240 to the service list for this matter.
2. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than June 21, 2016.
3. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of KCP&L.
4. The Commission's Public Information Officer shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of KCP&L and to the news media serving the residents of the service territory of KCP&L.
5. The Commission's Staff shall file its recommendation no later than July 1, 2016.
6. This order shall be effective when issued.




