On June 1, 2016<sup>1</sup>, Kansas City Power & Light Company filed tariff sheets to modify its Demand Side Investment Mechanism ("DSIM"). On July 1, Staff recommended the Commission reject the tariff sheets. Staff further recommends the Commission to direct KCP&L to file a corrected tariff sheet.

The Commission must rule on KCP&L's request to modify its DSIM no later than August 1. Thus, the Commission will order KCP&L to respond expeditiously.
