On November 22, 2016, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the company's Fuel Adjustment Rates ("FAR") pursuant to its Fuel Adjustment Clause ("FAC"). On December 22, 2016, the Staff of the Commission ("Staff") filed its *Staff Recommendation to Approve Tariff Sheet Regarding Change to the Fuel Adjustment Rate for Accumulation Period* 23, concluding Ameren Missouri had calculated the FAR correctly and recommending the Commission approve Ameren Missouri's tariff. On January 10, 2017, in response to an Office of the Public Counsel ("OPC") pleading, both Ameren Missouri and Staff affirmed Ameren Missouri had complied with all applicable rules for calculating the company's FAR. Furthermore, they stated that OPC did not allege that Ameren Missouri calculated the FAR incorrectly. No party disputed the January 10, 2017 pleadings. Thus, the Commission allowed the tariff to go into effect by operation of law on January 26, 2017. The file shall now be closed.
