# ORDER DIRECTING NOTICE AND ESTABLISHING INTERVENTION DEADLINE

Issue Date: December 8, 2016 Effective Date: December 8, 2016

On December 1, 2016, Kansas City Power & Light Company (KCP&L) filed a tariff to adjust the rate of its Demand Site Investment Mechanism Rider (DSIMR). KCP&L's tariff sheet bears an effective date of February 1, 2017, and consists of various rate components. The tariff sheet includes projected program costs and throughput disincentives related to its Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2 program for January 2017 through June 2017, and reconciliations for its MEEIA Cycles 1 and 2 programs through December 2016. Commission Rule 4 CSR 240-20.093(4), requires the Commission's Staff perform an examination of the information provided by KCP&L and determine if the proposed adjustments are in accordance with Section 393.1075, RSMo (Cum.Supp. 2013) and applicable regulations.

The Commission will establish a deadline for Staff to file its recommendation. Consistent with 4 CSR 240-3.163(9)(A), the parties to File Nos. EO-2014-0095 and EO-2015-0240 are automatically considered parties to this adjustment matter. The Commission will establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in KCP&L's service area. In addition, the Commission's Public Information Office shall make

notice of this order available to the media serving KCP&L's service area and to the members of the Missouri General Assembly representing the residents of KCP&L's service area.

#### THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall add all parties from File Nos. EO-2014-0095 and EO-2015-0240 to the service list for this matter.
- 2. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than December 23, 2016.
- 3. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of KCP&L.
- 4. The Commission's Public Information Officer shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of KCP&L and to the news media serving the residents of the service territory of KCP&L.
- 5. The Commission's Staff shall file its recommendation no later than January 12, 2017.
  - 6. This order shall be effective when issued.
