ORDER GRANTING APPLICATIONS TO INTERVENE

On May 22, 2018, the Commission received intervention requests from The Missouri Joint Municipal Electric Utility Commission in both files. Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary of that rule, more than ten days have elapsed since the applications to intervene, and no party has objected. Thus, the Commission will take up the applications for intervention unopposed.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. Upon review of the unopposed applications, the Commission finds that the applicant meets the standard in Commission Rule 4 CSR 240-2.075(4). Therefore, the Commission will grant the applications to intervene.

THE COMMISSION ORDERS THAT:

1. The applications to intervene filed by The Missouri Joint Municipal Electric Utility Commission are granted.
2. This order shall be effective when issued.
