**ORDER GRANTING MOTION FOR
SUPPLEMENTAL DIRECT TESTIMONY**

On April 23, 2018, the Staff of the Commission filed a Motion for Supplemental Direct Testimony in Furtherance of Staff’s Report on Distributed Energy Resources (“Motion”). In the Motion, Staff explains that in File No. EW-2017-0245, Staff filed a Report on Distributed Energy Resources (“Report”).

In the Report, Staff recommended the Commission to direct KCP&L and GMO to supplement its rate case direct testimony to address the Report. Specifically, Staff requests the Commission direct KCP&L and GMO to respond to the recommendations and submit exemplary tariffs, if applicable, related to demand response and the Indiana Model, explain whether those issues should be addressed in the rate cases or in MEEIA Cycle III cases, and more generally, provide any additional information on the companies’ plans related to distributed energy resources not already provided in their January 30, 2018, direct testimony.

Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary of that rule, more than ten days have elapsed since Staff filed the Motion, and no party has responded. Thus, the Commission will take up the Motion unopposed.

The Commission finds Staff's Motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission's Motion for Supplemental Direct Testimony in Furtherance of Staff's Report on Distributed Energy Resources is granted.
2. Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file supplemental direct testimony as described above no later than June 19, 2018.
3. This order shall be effective when issued.
