**ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND
DIRECTING FILING OF STAFF RECOMMENDATION**

On November 30, 2017, Kansas City Power & Light Company (“KCP&L”) filed an application to adjust its Demand Side Investment Mechanism Rider. Rule 4 CSR 240-20.093(4) requires the Commission’s Staff to examine and analyze the information KCP&L has submitted and to submit a recommendation to the Commission not later than 30 days after KCP&L filed its tariff revision. Because that 30th day falls on a Saturday, Staff’s recommendation will be due no later than Tuesday January 2, 2018. Under that rule, the Commission must then act on KCP&L’s filing by January 29, 2018.

The Commission will establish a deadline for any other entity that may wish to apply to intervene and will direct its Data Center to serve a copy of this order upon the parties in EO-2015-0240 and upon the county commission of each county in KCP&L’s service area. In addition, the Commission’s Public Policy and Outreach Department shall make notice of this order available to the media serving KCP&L’s service area and to the members of the Missouri General Assembly representing the residents of KCP&L’s service area.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall add all parties from File No. EO-2015-0240 to the service list for this case. Pursuant to Commission rule 4 CSR

240-3.163(9)(A), such party shall file a notice of intention to participate within the intervention period.

2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Kansas City Power & Light Company.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of Kansas City Power & Light Company and to the news media serving the residents of the service territory of Kansas City Power & Light Company.

4. Any proper person or entity wishing to intervene in this matter shall file an application to intervene no later than December 15, 2017.

5. The Staff of the Commission shall file its recommendation no later than January 2, 2018.

6. This order shall be effective when issued.
