## **ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE AND DIRECTING STAFF RECOMMENDATION**

Issue Date: January 2, 2018

Effective Date: January 2, 2018

KCP&L Greater Missouri Operations Company filed a tariff on December 29, 2017. Staff's recommendation is due no later than 30 days from that date<sup>1</sup> and the Commission will set a date for filing any reply to the recommendation.<sup>2</sup> Parties to the general rate case in which the Commission approved the fuel adjustment clause are parties to this case without having to file an application for intervention.<sup>3</sup> The Commission will direct its Data Center to add those parties to the service list. For anyone else, the Commission will set a deadline for filing an application to intervene.<sup>4</sup> The tariff bears a proposed effective date of March 1, 2018.

### **THE COMMISSION ORDERS THAT:**

1. Any application for intervention shall be filed no later than January 12, 2018.
2. Staff's recommendation shall be filed no later than January 29, 2018.
3. Any response to the recommendation is due on February 5, 2018.
4. The Commission's Data Center shall add to the service list all parties to the action in File No. ER-2016-0156.

6. The Commission's Public Information Office shall make this notice and order available to all members of the General Assembly serving persons within the service territories at issue.

7. This order shall become effective when issued.
