KCP&L Greater Missouri Operations Company filed a tariff on December 29, 2017. Staff's recommendation is due no later than 30 days from that date¹ and the Commission will set a date for filing any reply to the recommendation. ² Parties to the general rate case in which the Commission approved the fuel adjustment clause are parties to this case without having to file an application for intervention.³ The Commission will direct its Data Center to add those parties to the service list. For anyone else, the Commission will set a deadline for filling an application to intervene.⁴ The tariff bears a proposed effective date of March 1, 2018.

THE COMMISSION ORDERS THAT:

- 1. Any application for intervention shall be filed no later than January 12, 2018.
- 2. Staff's recommendation shall be filed no later than January 29, 2018.
- 3. Any response to the recommendation is due on February 5, 2018.
- 4. The Commission's Data Center shall add to the service list all parties to the action in File No. ER-2016-0156.
