**ORDER RECOGNIZING NAME CHANGE**

On January 19, 2018, ST Long Distance, Inc. d/b/a FairPoint Communications Long Distance requested that the Commission recognize its name change to ST Long Distance, Inc. d/b/a Consolidated Communications Long Distance. It also issued a revised tariff to reflect its new name. The revised tariff carries a February 19 effective date. The Staff of the Commission responded on February 2, 2018, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so. The revised tariff will be allowed to go into effect by operation of law on its effective date.

1. The Commission recognizes the name change of ST Long Distance, Inc. d/b/a FairPoint Communications Long Distance to ST Long Distance, Inc. d/b/a Consolidated Communications Long Distance.
