On February 1, 2017, the Office of the Public Counsel ("OPC") filed a Motion to Declassify Surveillance Monitoring Reports and Certain Testimony Discussing Those Reports and Motion for Expedited Treatment ("Motion"). OPC explains that KCPL has agreed to make those reports public. Designating those reports as public would expedite the hearing because the Commission would not need to go *in camera* to hear what would otherwise be confidential information. OPC asks the Commission to rule on the Motion no later than February 3, 2017.

The Commission will permit parties to respond.

THE COMMISSION ORDERS THAT:

1. Any party objecting to the Motion to Declassify Surveillance Monitoring Reports and Certain Testimony Discussing Those Reports and Motion for Expedited Treatment shall respond no later than February 2, 2017.
