which the Commission approved the fuel adjustment clause are parties to this case without

having to file an application for intervention.⁴ The Commission will direct its Data Center to

add those parties to the service list. For anyone else, the Commission will set a deadline

for filing an application to intervene.⁵ The tariff bears a proposed effective date of

September 23, 2016.

THE COMMISSION ORDERS THAT:

1. Any application for intervention shall be filed no later than August 11, 2016.
