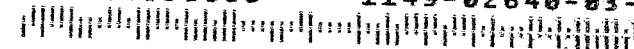

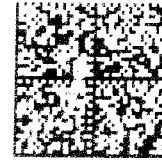

On June 30, KCP&L Greater Missouri Operations Electric Company filed the above-referenced applications and tariff.¹ No later than 30 days from that date, Staff's recommendation is due.² The Commission will set a date for filing a response to the recommendation.³

Parties to the general rate case in which the Commission approved the fuel adjustment clause are parties to this case without having to file an application for intervention.⁴ The Commission will direct its Data Center to add those parties to the service

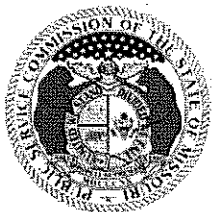

list. For anyone else, the Commission will set a deadline for filing an application to intervene.⁵ The tariff bears a proposed effective date of September 1.

THE COMMISSION ORDERS THAT:

1. Any application for intervention shall be filed no later than July 18, 2017.
2. Staff's recommendation shall be filed no later than July 31, 2017.
3. Any response to the recommendation is due on August 10, 2017.
4. The Commission's Data Center shall add to the service list all parties to the action in File No. ER-2007-0004.
5. The Commission's Data Center shall send this notice and order to all parties to the action in File No. ER-2007-0004.
6. The Commission's Public Policy and Outreach Department shall make this notice and order available to all members of the General Assembly serving persons within the service territories at issue, and to the news media serving the service territories at issue.
7. This order shall be effective when issued.




