Kansas City Power & Light respectfully requests that the accompanying be filed. The accompanying filing is made subsequent to the withdrawal of a similar filing for JE-2008-0157 concerning Net Metering wherein Staff and Company agreed to certain modifications in language predominantly concerning customer-generator liability insurance requirements.

Accompanying sheets issued by the Kansas City Power & Light Company are sent to you for filing with the Missouri Public Service Commission.

In summary, in its efforts to promote environmentally friendly Customer-Generator renewable fuel source generators the Company proposes to re-establish Sheets 40-40B, "Reserved For Future Use", as Sheets 40-40B, Net Metering For Renewable Fuel Sources. Additionally Sheets 34-34E Net Metering revised to Sheets 34-34F Net Metering Interconnection Agreement to distinguish between the Net Metering For Renewable Fuel Sources and this (Sheets 34-34E) net metering retail interconnection agreement. Also provided for revision is the Company's Missouri Rate Table of Contents incorporating the label change from Net Metering (Sheets 34-34E) to Net Metering Interconnection Agreement, the implementation of Net Metering For Renewable Fuel Sources (NMRF), Sheets 40-40B.


