On March 23, 2018, Union Electric Company d/b/a Ameren Missouri submitted its 24th Fuel Adjustment Clause (FAC) true-up filing (File No. ER-2018-0256) and a tariff sheet to adjust the company's FAC for the 27<sup>th</sup> accumulation period (File No. ER-2018-0255).
