ORDER APPROVING COMPLIANCE TARIFF

Issue Date: July 19, 2018

Effective Date: August 1, 2018

On July 5, 2018, the Commission approved a unanimous stipulation and agreement that will reduce Union Electric Company d/b/a Ameren Missouri's electric rates. By approving that stipulation and agreement, the Commission authorized Ameren Missouri to file a tariff to adjust its rates as determined in that stipulation and agreement. Ameren Missouri filed its compliance tariff on July 16.

Ameren Missouri's compliance tariff carries a 30-day effective date that would put the tariff in effect on August 15. However, Ameren Missouri filed a motion along with its tariff asking the Commission to expedite its consideration of the compliance tariff and to approve the tariff to go into effect on August 1.

Upon receiving Ameren Missouri's motion for expedited approval of its tariff, the Commission issued an order on July 17, directing its Staff to file a recommendation regarding Ameren Missouri's tariff by July 18. That order also directed any other party wishing to file a recommendation regarding Ameren Missouri's tariff to do so no later than July 18.

On July 18, the Commission's Staff filed its recommendation regarding Ameren Missouri's compliance tariff and motion for expedited treatment. Staff concludes the tariff complies with the Commission's Order Approving Stipulation and Agreement, and recommends the Commission approve the compliance tariff to be effective on August 1. No other party filed a recommendation, and no party has filed a response to Staff's recommendation. The Commission has reviewed the proposed tariff and Staff's recommendation. The Commission concludes the submitted compliance tariff is consistent with the approved stipulation and agreement. Expedited approval of the tariff is appropriate because the Commission has found that the rates resulting from the approved stipulation and agreement are just and reasonable. Thus, for good cause shown pursuant to Section 393.140(11), RSMo 2016, the Commission will approve Ameren Missouri's tariff to become effective for service rendered on and after August 1, 2018.

THE COMMISSION ORDERS THAT:

1. The proposed tariff submitted under Tariff No. YE-2019-0004 by Union Electric Company d/b/a Ameren Missouri on July 16, 2018, as substituted on July 17, 2018, is approved, effective on and after August 1, 2018.

2. This order shall become effective on August 1, 2018.

3. This file shall be closed on August 2, 2018.
