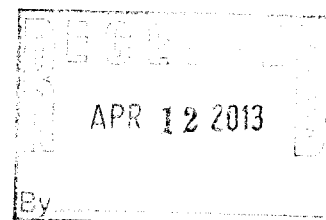
In addition, I am confirming that Broadband contacted the Missouri USF Administration on that same date through its website and notifying the Administrator where and to whom all future correspondence can be directed.
